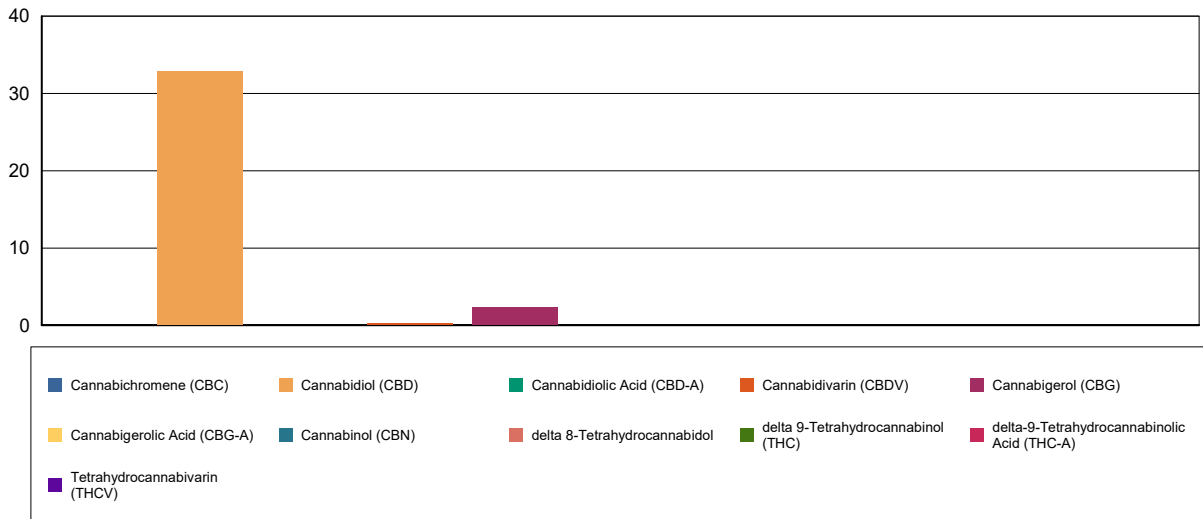

Following USDA guidelines on uncertainty, Altitude Consulting's uncertainty are calculated for CBDa and CBD at +/- 4%.  
 The uncertainty for THCa and THC are +/- 5%. This implies the range for a 10% value of CBD to be 9.6-10.4%. The uncertainty range for a 0.30% value of THC would be 0.28-0.32%.
